## **INFORMATION WE MAY COLLECT FROM YOU**

We may collect and process the following data about you:

- Information that you provide by filling in forms on our site [www.photospecialist.co.uk](http://www.photospecialist.co.uk) (our site). This includes information provided at the time of registering to use our site, subscribing to our service, posting material and or requesting further services. We may also ask you for information when you report a problem with our site.
- If you contact us, we may keep a record of that correspondence.
- We (and our affiliates on our behalf) may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- Details of transactions you carry out through our site and of the fulfilment of your orders.
- Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

## **IP ADDRESSES**

We may collect information about your computer (including where available your IP address, operating system and browser type) for system administration and to report aggregate information to our advertisers. This is statistical data about our users’ browsing actions and patterns, and does not identify any individual.

## **COOKIES AND OTHER DATA**

For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on your browser or the hard drive of your computer. Cookies contain information that is transferred to your computer’s hard drive. They help us to improve our site and to deliver a better and more personalised service. Some of the cookies we use are essential for the site to operate. If you register with us or if you continue to use our site, you agree to our use of cookies.

## USES MADE OF THE INFORMATION

- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use ([http://static.fotokonijnenberg.nl/files/Terms-of-Use\\_FotoKonijnenberg.pdf](http://static.fotokonijnenberg.nl/files/Terms-of-Use_FotoKonijnenberg.pdf)) or terms of
